TERMS & CONDITIONS

Tuition fees are reviewed annually by 1st July and are to be paid according to the schedule set by the Board.

Tuition Payment Options

- One annual payment - due by the first day of Term 1
- Four equal term/quarterly payments - due by the first day of each term
- Ten equal monthly payments - due on the last day of each month starting January

Late Payment

In an effort to ensure we receive school fees on time and limit human resources towards collecting debts, please note that those who do not set up a payment plan or coordinate with the finance department will be subject to the following...

- At the end of week 1 of the term: A 3% late fee will be added.
- At the end of week 2 of the term: An additional 5% late fee will be added.
- At the end of week 3 of the term: Enrollment will be suspended.

Placement Fee

A compulsory part of tuition billed and due by the end of November of the previous year. Payment of the placement fee secures your spot for the following year and covers initial material costs including workbooks, exercise books, etc. This is not refundable. Students who are enrolled after the due date pay the placement fee before commencement.

Building Levy

The building levy is a one-off fee for all international students (foreign passport holders/non-citizens) enrolled for the first time. It is paid upfront or divided over the first year's payments.

PTFA Levy

PTFA levy is per family and added to annual tuition fees and administered by the PTFA on behalf of the parents and teachers.

Discounts

We offer a discount to non-citizen private fee paying families who have been enrolled at Woodford for five consecutive years. After five consecutive years of enrollment, the tuition of all students in the family will drop to the citizen rate.

Pro rata Arrangements

Students who enroll after the fourth week of term are entitled to pay a pro rata figure for weeks attended.

Term Leave

Students who are absent for an entire term pay 50% of the fees to hold their place, otherwise students will be considered to have withdrawn.

Withdrawal

A term's notice is required to withdraw a student from school. If a student is absent from school for longer than five weeks due to non-payment of fees, or an un-notified absence (in writing), they shall be considered as having been withdrawn. Should re-enrollment follow, all fees shall apply as are due for a new enrollment.

- No student will be allowed to register for school until all arrears from the previous year are fully paid (or a written agreement regarding a payment schedule has been made with the finance team and HOS).
- Any students in Term 1 who have not fully paid up Term 1 fees by week 5 will be withdrawn from classes until debts are paid or arrangements made in writing with the finance team and HOS.
- In Terms 2, 3 and 4, students with unpaid fees for that term will be refused entry to classes from Day 1.
- Reminders will be sent by the School on due payment dates. A follow up phone call may be made by the finance team and/or Head of School.
